The meeting was held for organizational purposes. Town Council President opened the meeting and explained the role and responsibility of the Redevelopment Commission.


Jim Brown volunteered for the role of President and all voted aye.

The meeting was adjourned at 6:18 PM.






The Open Door law about meetings was discussed.

Those in attendance were commission members: Jim Brown, Scott Ailes, Mike Cook, Brian Hole and Lee Fletcher. Patrons in attendance were: Katie Conyer, Shane Childress, Brenda and Dave Phelps.

The meeting was called to order at 6:00 PM by Jim Brown. The Minutes of the January 4, 2016 meeting were read and approved upon a motion from Scott Ailes, seconded by Brian Hole.

Election of officers was held for the current year. Brian Hole made a motion, seconded by Mike Cook to re-appoint the officers as they currently stand; Jim Brown as President, Scott Ailes as Vice President, and Lee Fletcher as Secretary. The motion carried unanimously.


Jim Brown shared information concerning the Tax Increment Funding (TIF) and what efforts have been made by the Town Board, the Jamestown Community Partnership along with the Office of Community Rural Affairs (OCRA) and the local Civic Organizations to make progress in the town becoming compliant with IC 36-7-14.

Dave Phelps from the Jamestown Area Partnership shared information that the organization is focusing on the downtown area and looking into what is/should be designated as downtown.

The members of the Jamestown Redevelopment Commission will be meeting with principals of the Boone County Redevelopment Commission as well as the town attorney, Amy Nooning, to learn more about TIF. The date has not yet been set.

A motion was made by Lee Fletcher, seconded by Scott Ailes to adjourn. The motion carried unanimously.
